

The Council of the Christian Island Band of Indians at a meeting held this 27th day of October 1921, with the following objects in view to amend the provisions of Section 3 of the Indian Act.

By-Law No. 1

A by-law to provide for the regulation of pheasant hunting on the Christian Island Indian Reserve in the Province of Ontario.

In this by-law

- (a) "Band" means the Christian Island Band of Indians;
- (b) "Council" means the Council of the Band;
- (c) "General list member" means any person resident on the Christian Island Reserve whose name is entered on the general list pursuant to Section 6 of the Indian Act;
- (d) "guide" means any member of the Band licensed to act as a guide pursuant to this by-law;
- (e) "permit" means a permit issued for the purposes of this by-law by the Council or a person appointed in writing by the Council for the issuing of such permits;
- (f) "Registrar" means a person appointed in writing by the Council for the purposes of this by-law; and
- (g) "Reserve" means the Christian Island Indian Reserve.

2. No person other than a member of the Band or a General list member shall hunt pheasant on the Reserve without a permit.
3. No member of the Band or General list member shall invite or accompany any person who is not a member of the Band or a General list member to hunt pheasant on the Reserve unless such person is the holder of a permit.
4. Permits may be obtained only on production of valid and subsisting Ontario provincial hunting licence and may be subject to a fee established from time to time by resolution of the Council.
5. Bag limits, possess limits, hunting hours, and regulations for the use of dogs may be established from time to time by resolution of the Council.
6. (1) Holders of permits may hunt pheasants only when accompanied by a guide.  
(2) Fees and any other matters respecting guide services and the employment of guides may be determined and regulated from time to time by resolution of the Council.

17. Any person of the Band residing on or near a guide for the purposes of this by-law shall register with the Registrar.
18. The Registrar may at the discretion issue up to a period of three days as the Council may determine by resolution or may have power to suspend pursuant to subsection (1), a license to guide.
19. No Band member shall act as guide for the purposes of this by-law unless licensed pursuant to subsection (1) of Section 7.
20. (1) Every guide shall abide by any rules and regulations established from time to time by resolutions of the Council for the instructions of guides.
- (2) Where any guide fails to abide by any rules and regulations established pursuant to subsection (1), the Registrar may revoke the license of such guide.
21. Open seasons and any other matters not provided for in or pursuant to this by-law with respect to the hunting of pheasants on the Reserve shall be as provided for in the regulations made under the Ontario Game Act for provincial lands contiguous to the Reserve.
22. Any person who violates any of the provisions of this by-law shall or ~~may~~ be liable to a fine not exceeding \$100 or imprisonment for a term not exceeding thirty days or both fine and imprisonment.
23. With the coming into force of this by-law

Repeal

A by-law made by the Council on November 1, 1961 to provide for the regulation of pheasant shooting on Christian Island Reserve shall cease to be in force.

1. The purpose of this by-law is to regulate the hunting of game on the Christian Island Indian Reserve and to provide for the preservation of the same.

- (a) "Band" means the *Band of Christian Island Indian*;
- (b) "Council" means the *Council of the Band*;
- (c) "General List member" means any person entitled on the Christian Island Reserve whose name is entered on the general list pursuant to Section 6 of the Indian Act;
- (d) "guide" means any member of the Band licensed to act as a guide pursuant to this by-law;
- (e) "permit" means a permit issued for the purposes of this by-law by the Council or a person appointed in writing by the Council for the issuing of such permits;
- (f) "Registrar" means a person appointed in writing by the Council for the purposes of this by-law; and
- (g) "Reserve" means the Christian Island Indian Reserve.

2. No person other than a member of the Band or a General List member shall hunt pheasant on the Reserve without a permit.
3. No member of the Band or General List member shall invite or accompany any person who is not a member of the Band or a General List member to hunt pheasant on the Reserve unless such person is the holder of a permit.
4. Permits may be obtained only on production of valid and subsisting Ontario or Federal hunting licence and may be subject to a fee established from time to time by resolution of the Council.
5. The Council may, from time to time, make regulations for the use of the Reserve and may, from time to time, vary or amend such regulations.
6. The Council may, from time to time, employ a guide.
7. The Council may, from time to time, employ the employment of a guide.
8. The Council may, from time to time, employ the employment of a guide.

7. (1) Any member of the Band wishing to act as a guide for the purposes of this by-law shall register with the Registrar
- (2) The Registrar may at his discretion issue or on payment of such fee as the Council may determine by resolution, to any Band member registered pursuant to subsection (1), a licence to guide.
8. No Band member shall act as guide for the purposes of this by-law unless licensed pursuant to subsection (2) of Section 7.
9. (1) Every guide shall abide by any rules and regulations established from time to time by resolutions of the Council for the instructions of guides
- (2) Where any guide fails to abide by any rules and regulations established pursuant to subsection (1), the Registrar may revoke the license of such guides.
10. Open seasons and any other matters not provided for in or pursuant to this by-law with respect to the hunting of pheasants on the Reserve shall be as provided for in the regulations made under the Ontario Game Act for provincial lands contiguous to the Reserve.
11. Any person who violates any of the provisions of this by-law shall on ~~conviction~~<sup>summary</sup> conviction be liable to a fine not exceeding \$100 or imprisonment for a term not exceeding thirty days or both fine and imprisonment.
12. With the coming into force of this by-law
