DO HEREBY RESOLVE:  
DECIDE, PAR LES PRÉSENTES:

WHEREAS; the abuse of intoxicants represents a major threat to the communal well-being of the Cat Lake First Nation and to the lives of it's members;

WHEREAS; the abuse of intoxicants has been demonstrated to be a major contributor to ill-health, social disorder and to breaches of the public peace within the community;


WHEREAS; it is necessary for the effective control of intoxicants to take special measures which respond to the unique constitutional position of the Cat Lake First Nation in Ontario and in Canada, it's location, and it's unique history, traditions and culture;

WHEREAS; on July 22, 1993, the members of the Cat Lake First Nation, having considered and discussed these matters at a series of public meetings and desiring to prohibit the use of intoxicants within Cat Lake First Nation, voted on and approved by a majority the Law Respecting Intoxicants;

WHEREAS; the by-law to the Minister of Indian Affairs, through a clerical error, unintentionally omitted the word "not" in section 8 (c)

THEREFORE; the Cat Lake First Nation hereby corrects the by-law to properly reflect the decision made by vote of it's members July 22, 1993;



AND THEREFORE; Section 8 of the Law Respecting Intoxicants as corrected reads:

"S.8 No offence is committed where an intoxicant is possessed, used or intended to be used solely,


- (a) in accord with this law;
- (b) for medicinal purposes;
- (c) for personal, domestic, or traditional or other purposes which do not involve producing a state of intoxication; or,
- (d) where an intoxicant is being transported by a non-member of the Cat Lake First Nation or by any other person who is not resident of the Cat Lake First Nation through the First Nations territory, and the person transporting the intoxicant has, upon being asked, declared that he or she is in possession of an intoxicant and is transporting it through the First Nation territory.";

AND; the Cat Lake First Nation submits the by-law in its corrected form to the Minister of Indian Affairs pursuant to s. 85.1 of the Indian Act.


"(c) for persons, domestic, or traditional or other purposes which do not involve producing a state of intoxication";


The section in it's entirety therefore reads, as is consistent with the intent of the community on July 22, 1993;
