BY-LAW NO. 2-00

Of the Wauzhushk Onigum Nation A By-Law for the Prohibition of Littering

WHEREAS: the Council of Wauzhushk Onigum Nation desires to make a by-law for the prohibition of littering, with respect to any matter arising out of or ancillary to the exercise of powers under section 81 of the Indian Act and for the imposition of a penalty for a violation thereof;

AND WHEREAS: the Council of the Wauzhushk Onigum Nation is empowered to make such by-law pursuant to paragraph 81(1)(a), (b), (c) and (d) of the Indian Act;

AND WHEREAS: it is considered to be expedient and necessary for the health of the residents, the prevention of diseases and nuisances and for the overall appearance of the Reserve to provide for the prohibiting of littering on the reserve;

NOW THEREFORE, the Council of Wauzhushk Onigum Nation hereby makes the following by-law:

Short Title

This by-law may be cited as the "Littering Control By-Law".

Interpretation

2. In this by-law,

"Band" means Wauzhushk Onigum Nation;

"Council" means the Council of the Wauzhushk Onigum Nation;

"Litter" includes but is not limited to garbage, landfill, scrapes of all kinds and any combination of thereof, left or abandoned left or abandoned on the Reserve in contravention of this by-law and littering has a corresponding meaning.

"Reserve" means the reserve set apart for the use and benefit of the Wauzhushk Onigum Nation and includes the Band's reserve No.38B.

Littering Prohibited

3. Subject to paragraph 4, no person shall abandon any litter on the Reserve.

Enforcement

4. A resident member of the Band may abandon litter on the Reserve only in a place, receptacle or area approved by the Council for receiving such litter.

Penalty

5. Every person who fails or refuses to comply with a provision of this by-law commits an offence.

General

6. A person who commits an offence under this by-law is liable on summary conviction to a fine not exceeding \$1,000 or to imprisonment for a term not exceeding thirty (30) days, or to both.

Should a court determine that a provision of this by-law is invalid for any reason, the provision shall be severed from the by-law and the validity of the rest of the by-law shall not be affected.

This by-laws come into force 40 days after the date of mailing to the Minister of Indian and Northern Development as required pursuant to section 52 of the Indian Act.

9. The provisions of this by-law apply to all lands of the Reserve of the Wauzhushk Onigum Nation.


