DO HEREBY RESOLVE:  
DÉCIDE, PAR LES PRÉSENTES:

At a meeting of the Lower Kootenay Indian Band held March 13, 1980 it was determined by concerned Band members and adopted by the Band Council that the continuing use of Alcohol and/or Drugs or both within the Boundaries of Lower Kootenay has contributed substantially to the lowering of the quality of life in our community. Therefore, by Order of the Band members, all members of Lower Kootenay, non-members and people from outside of the community are advised that the use of Alcohol and/or Drugs on and within a One (1) mile radius of Lower Kootenay is henceforth prohibited.

The following By-Law was written and adopted by the Band Council. This By-Law reflects the Band Council and concerned members continuing efforts to improve the quality of life for Indian People. THEREFORE, in accordance with the Indian Act, specifically Section 81 of the Act, the Lower Kootenay Band hereby makes and passes the following By-Law, to be known as By Law #5.

"That the use of Alcohol and/or Drugs significantly contributes to the ill-health and general lack of well-being among Indian People; Therefore, as a preventative measure" We ban the use of Alcohol and/or Drugs on the Lower Kootenay Reserve.
