DOIG RIVER INDIAN BAND

A BY-LAW TO CONTROL THE PRESENCE, TRADE AND USE
ON INTOXICANTS ON RESERVE

1. This By-Law may be cited as the Doig River Indian Band Intoxicants By-Law.
2. In this By-Law
 "Band" means the Doig River Indian Band;
 "Intoxicant" includes alcohol, alcoholic, spiritous, vinous, fermented malt or other intoxicating liquor or combination of liquors and mixed liquor a part of which is spiritous, vinous, fermented or otherwise intoxicating and all drinks or drinkable liquids and all preparations or mixtures capable of human consumption that are intoxicating;
 "Reserve" means any tract of land that has been set apart by Her Majesty for the use and benefit of the Doig River Indian Band.

PROHIBITIONS:

3. The sale, barter, supply or manufacture of an intoxicant by any person on our Reserve is hereby prohibited.
4. Subject to Section 6, the possession of an intoxicant by any person on our Reserve is hereby prohibited.
5. The intoxication of any person on our Reserve is hereby prohibited.

EXCEPTIONS:

6. No offence is committed against Section 4 of this By-Law if the possession of an intoxicant is
 (a) for medicinal purposes;
 (b) for the pursuant to Section 9; or across our Reserve to a destination not within the boundary of our Reserve to a destination not within the boundary of our Reserve and the container of the



7. Any person who contravenes Section 3 of this By-Law is guilty of an offence and is liable on summary conviction to a fine of not more than \$1,000. or to imprisonment for a term not exceeding six months or to both.

8. Any person who contravenes Sections 4 or 5 of this By-Law is guilty of an offence and is liable on summary conviction to a fine of not more than \$100 or to imprisonment for a term not exceeding three months or to both.

This By-Law made this 27 day of December, 1985 by th Council of the Doig River Indian Band, and with the consent of the majority of the electors of the Band who voted at a Special Meeting of the Band called by Council of the Band for the purpose of considering this By-Law.
