DO HEREBY RESOLVE;  
 DÉCIDE, PAR LES PRÉSENTES: #1

To enact a by-law respecting the preservation, protection and management of oysters and oyster beds;

Whereas paragraph (10) and (P) of Section 81 of the Indian Act empower the Council of an Indian Band to make by-laws respecting the preservation, protection and management of fur-bearing animals, fish and other game on the reserve; and provide for the removal and punishment of persons trespassing on the reserve or frequenting the reserve for prescribed purposes;

And Whereas Chapel Island Band Members possess oyster leases respecting territory at Chapel Island Indian Reserve # 5;

Now Therefore the Council of the Chapel Island Band of Indians enacts as a by-law thereof the following:

1. That members of the Chapel Island Band possessing oyster leases at Chapel Island Indian Reserve # 5 shall be permitted to use SCUBA equipment for the preservation, protection and management of the oysters on their respective leases.
2. The Council shall henceforth be responsible for the punishment and removal of persons trespassing upon the said oyster leases.

4. In this by-law:
  - A. "Council" means the Council as defined in the Indian Act, of the Chapel Island Band of Indians.
  - B. "Reserve" means the tract of land set apart by Her Majesty within the definition in the Indian Act for the use and benefit of the Chapel Island Band of Indians.
