BY-LAW NO. 12

The Council of the Peguis Band of Indians at a meeting held this 29th day of August, 1984, hereby enact By-Law Number 12 to provide for the assessment of a Users Fee for Band Members that are not on Social Assistance for their contribution to cover the cost of providing Water, Sewer, and Sanitation Services on the Peguis Reserve.

Whereas, Paragraph (f) of Section 83 of the Indian Act empowers the Council of a Band to make By-Laws respecting the raising of money from Band Members to support Band Projects.

Therefore, the Council of the Peguis Band enacts as a By-Law of the following:

- 1.) In this By-Law:
 - (a) "Council" means the Council, as defined in the Indian Act of the Peguis Band of Indians;
 - (b) "Reserve" means the tract of land set apart by Her Majesty within the definition of the Indian Act, for the use and benefit of the Peguis Band of Indians known as Peguis Reserve No. 1B;
- 2.) All Band Members that are not on Social Assistance shall be assessed a "Users Fee" of \$18.80 per month as their contribution towards the cost of the provision of Water, Sewer, and Sanitation Services from the Peguis Band.
- 3.) Band Members that are not on Social Assistance and who do not wish to participate in this Users Fee Program will be responsible for arranging for the provision of Water, Sewer, and Sanitation Services at their own cost.

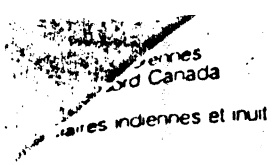

 DÉCIDE, PAR LES PRÉSENTES:

WHEREAS, the Peguis Band has agreed to implement a "User Fee Program" to cover the cost of providing water, sewer, and sanitation services to the reserve;

WHEREAS, the Department of Indian and Northern Affairs allows \$18.80 per household per month for welfare clients and;

WHEREAS, the Band is prepared to assess a fee of \$18.80 for other Band Members that are not on Social Assistance for their contribution to the maintenance of homes on the reserve;

THEREFORE, BE IT RESOLVED THAT, the Peguis Band requests a contribution from the Department of Indian and Northern Affairs, Social Services Program in the amount of \$102,422.40 based on 454 welfare clients at \$18.80 per client.
