DO HEREBY RESOLVE: The Crane River Band of Indians #27  
 DÉCIDE, PAR LES PRÉSENTES: By Law Number 7  
 Being a By-Law to Provide for the regulation of Traffic

WHEREAS, Paragraphs (b) and (r) of Section 81 of the Indian Act empower the Council of a Band of Indians to make by-laws respecting the regulations of traffic and the imposition of a penalty for the violation thereof now,




WHEREAS, It is deemed to be expedient to control the passage of vehicles on public roads and for the parking of vehicles on Reserve land and for the safety and welfare of the inhabitants of the Crane River Indian Band No. 279; and further to by-law number 4 regulating traffic.

THEREFORE, THE Council of the Crane River Band of Indians makes a by-law thereof as follows:

- No Parking Area/Service Parking**  
No person other than delivery and service vehicles shall park any vehicles within that portion of the reserve known as the "Hall and Restaurant" and marked in yellow on the map "Schedule A" attached hereto and signs to that effect shall be erected at all entrances to the said "No Parking" area.
- Public Parking Area**  
Any person may park their vehicle within that portion of the reserve known as the "Hall and Restaurant" and marked in blue on the map "Schedule A" attached hereto and signs to that effect shall be erected at all entrances to the said "Public Parking" area.

DO HEREBY RESOLVE: continued; From the Council of the Crane River Band of Indians  
 DÉCIDE, PAR LES PRÉSENTES: Makes a By-Law thereof as follows:

- Exit Only  
 No person shall operate a vehicle so as to enter from that portion of the reserve road west of the Hall and Restaurant and marked in green on the map "Schedule A" attached hereto and signs to that effect shall be erected at both sides of the said exit only area.
- All traffic signs required by this by-law shall be erected in accordance with by-law number 4 governing such signs and passed on the 19th day of September, 1986.
- Any person who violates any of the provisions of this by-law shall be liable on summary conviction to a fine not exceeding one hundred dollars or imprisonment for a term not exceeding thirty days, or to both fine and imprisonment.

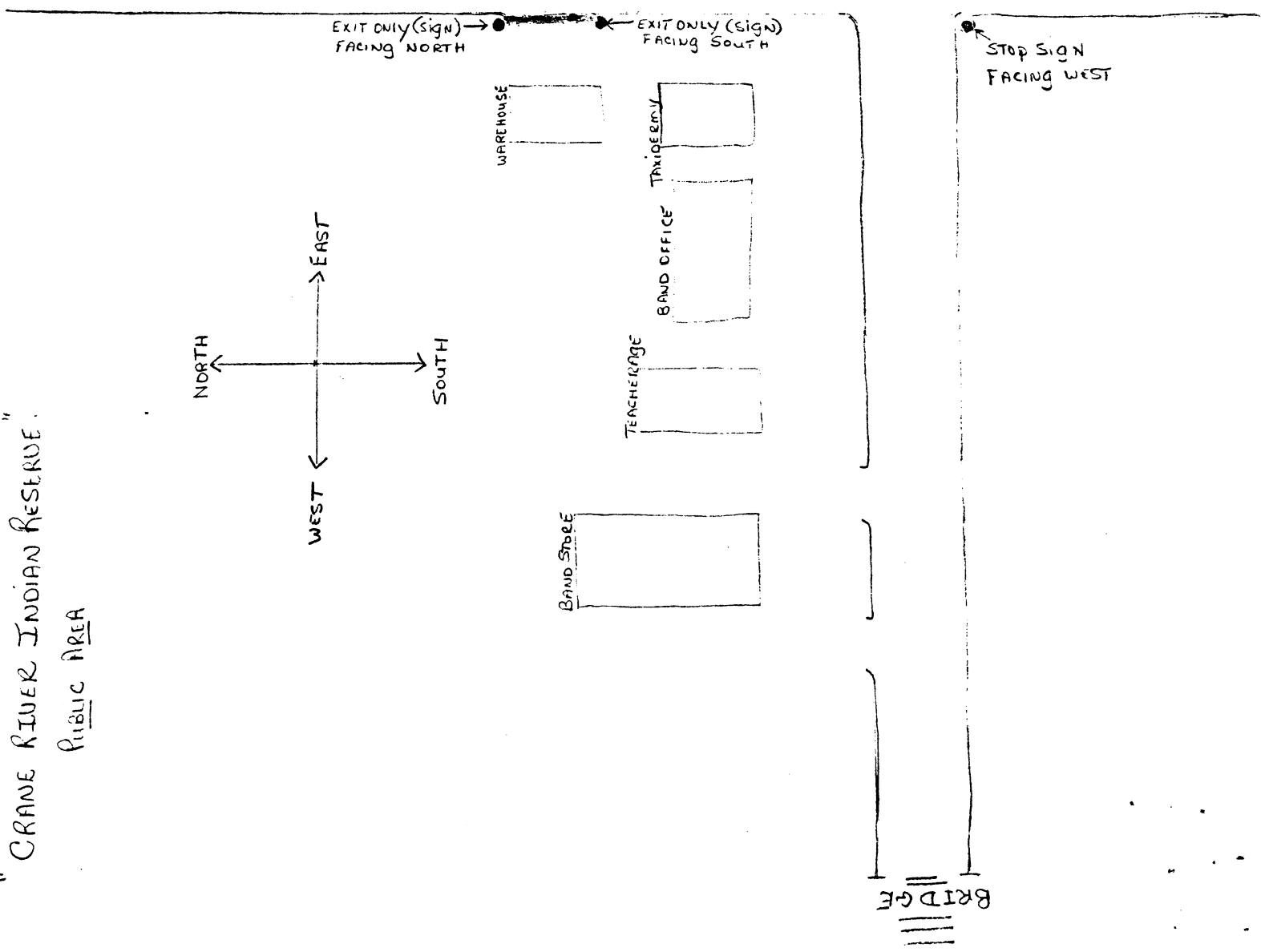
