A BY-LAW TO REPEAL THE INTOXICANTS BY-LAW**

WHEREAS a majority of the electors of the Bloodvein First Nation voted on the referendum of the Bloodvein First Nation on October 26th, 1992 called by the Council of the Bloodvein First Nation to decide whether to repeal the Intoxicant By-Law No. 1290 whose effective date was February 6th, 1990;

NOW THEREFORE, it is hereby enacted:

1. By-Law number 1290 enacted on the 6th day of February, 1992, and being a By-Law to prohibit Intoxicants within the boundaries of the Bloodvein First Nation, is hereby repealed.

THIS BY-LAW IS HEREBY made at a duly convened meeting of the Council of the Bloodvein First Nation this 26th day of October, 1992.

Now therefore it is resolved that INAC assist and take all the necessary steps for the recognition and implementation of this By-Law


That the product known as Hairsprays is prohibited from entering or being sold on the reserve


That for Violation of the By-Law, the imposition on summary conviction fine not exceeding \$1,000.00 or imprisonment for a term not exceeding 30 days or both


