NOW THEREFORE, the Council of the Birdtail Sioux Band of Indians enacts as a by-law thereof the following;

BY-LAW number 1-R-77 enacted and being a by-law to repeal by-law number 1 effecting administration and financial regulation for the Birdtail Sioux Band Council and their employees and enacted on May 28, 1971, is hereby approved and passed at a duly convened meeting of the Council of the Birdtail Sioux Band this 22nd day of August, 1977.
