DO HEREBY RESOLVE:

THAT the Council of the Key Band of Indians at a meeting held January 4, 1971, make the following by-law:

By-Law Lo. 2

To establish a position of Band Administrator, WERREAS it is necessary to appoint a Band Administrator to provide a service to the Band Lembers and to carry out the wishes of the Band Council. THEREFORE, the Council of the Loy Band enect as follows:

- 1. THAT the position of Band Administrator is hereby created in accordance with the policy of the Band Council expressed by resolution.
- 2. This the position shall be filled in accordance with the policy of Band Council expressed by resolution.
- 3. THAT the incumbent of the said position shall hold office during the pleasure of Council and subject to the By-laws of the Fand Council.
- 4. That the said incurred shall file with the Band Corneil an indennity bond, in a sum adequate to ensure protection of moneys entrasted to his care, issued by a recognized bonding company, subject to the premium of such bond being peid from the Key Band Trust Account.
- 5. THAT the said incumbent shall be paid a salary of \$7,200, per annum peid on a semi-monthly basis. Such salary may be adjusted by Band Council resolution according to the increase or decrease of responsibility of the position and that this shall be on the basis of a 40-hours week.
- 6. THAT the salary of the said incumbent shall be payment in full for all services required of him and all fees or salaries of any kind occurring to him by virtue of any Act or Statute of the Federal or Provincial Covernments or of any Ey-law

- THAT the duties of the Band Administrator shall be as follows:
 - (a) To file before taking over his duties as Bend Administrator a Declaration of Cath of Office and Secrecy on Form SL L.
 - (b) To attend all regular and special meetings of the Council and to renowt as required the activities carried out by the incumbert.
 - (c) To keep in his office a record of all applications, decision sheets and other relative documents.
 - (d) To act as a intake worker for all matters; to interpret such services to the members of the Key Band; to assist and advise on child care and retabilitation of physical and mentally disabled persons, assist in locating fester homes on the reserve and surrounding area; work with natural parents to strengthen homes to keep their children.
 - (e) To administer by making decisions, by preparing checkes and other commentation adequate to justify the payments of accounts and to compile and gather statistics relative to 'elfare Services.
 - (f) TEAT the Baksatchewan Assistance Plan, as adopted by the Federal Department of Indian Affairs & Northern Development, shall be the criteria basis for the issuing of Social Assistance.
 - (6) To co-operate with Social Services of the Pepartment of Indian Affairs & Worthern Development and obtain their advise on matters in which clearly defined policies are not available.
