DO HEREBY RESOLVE:      That we, the Chief and Council of the Indian Brook  
 DÉCIDE, PAR LES PRÉSENTES:      Reserve, have met and agreed to enforce a by-law on the reserve, for  
 the service and maintenance of the water and sewer system.

The service charge of \$5.00 (five dollars) per month to be assessed each house being serviced by the present system of water and sewer.

The assessment of \$2.50 (Two dollars and fifty cents) to members not presently being serviced by any sewer system, until such time as the sewer system is extended to facilitate the needs of these people. Once connected to the main sewer system, the assessment will be increased to comply with the full service rate.

This by law to be in force for an indefinite period.

This by law submitted in compliance with Section 80 of the Indian Act.

This Band operates under Section 68 of the Indian Act.
