BY-LAW 1995.1

**A BY-LAW TO AMEND BY-LAW 1991.4
(as amended by by-laws 1992.3 and 1994.1)
DIVIDING THE RESERVE INTO ZONES
AND REGULATING THE USE OF THE LAND**

WHEREAS paragraphs 81(1)(g), (q) and (r) of the **Indian Act** empower the council of an Indian Band to make by-laws respecting the dividing of the reserve into zones and regulating the use of the land and the imposition of a fine for violation of any by-laws made under that section;

AND WHEREAS the council of the Millbrook Band did enact by-law numbers 31, 34 and 1991.4 respecting the dividing of the reserve into zones and regulating the use of the land on the reserve;

AND WHEREAS it was merely an oversight that by-law number 1991.4 did not explicitly repeal by-law number 34 (which by-law had repealed by-law 31);

AND WHEREAS it was the intent of the council of the Millbrook Band in 1991, which intent is evidenced from the scope of by-law number 1991.4, that the zoning for Cole Harbour established in by-law number 1991.4 should, from the date that by-law came into force, replace the zoning established for Cole Harbour in 1989 in by-law number 34;

AND WHEREAS the council of the Millbrook Band did enact by-law number 1991.4 respecting the dividing of the reserve into zones and regulating the use of the land on the reserve:

AND WHEREAS the council of the Millbrook Band did amend the said by-law number 1991.4 in August 1992 by enacting by-law number 1992.3;

AND WHEREAS the council of the Millbrook Band did further amend the said by-law number 1991.4 in December 1994 by enacting by-law number 1994.1;

AND WHEREAS the said council deems it expedient and in the best interest of the Millbrook Reserve to formally repeal by-law 34 and to further amend the said 1991 by-law, as amended;

NOW THEREFORE the council of the Millbrook Band enacts as a by-law the following:

1. By-law number 34 shall be, and the same is hereby, repealed effective the date by law 1991.4 came into force.
2. Section 25(1)(q) of by-law number 1994.1 shall be, and the same is hereby, further amended by deleting the words A bingo and.

- 3. Section 22 of by-law 1991.4, as amended by by-law 1994.1, shall be, and the same is hereby, further amended by adding the following sentence after the lists of Zones and Zone Symbols:

The zoning map (Schedule "A" referred to in the said section 22 to by-law 1991.4) shall be, and the same is hereby, amended to show the Band Economic Development Zone as being the land situated along Highway 102 on the Millbrook Reserve and the land situated along Caldwell Road on the Cole Harbour Reserve which were zoned as Commercial until the present by-law comes into force.






