Make this by-law pursuant to paragraph c,d,r,of Section 81  
of the Indian Act.

By-law #6

A by-law to provide for the regulation of carrying of  
fire arms within the Reserve.

Article 1

No person actually or under the age of 14 years shall  
carry a fire arm within the boundaries of the Reserve.

Article 2~~XX~~

NO person shall upon any street or road within the Reserve  
discharge any firearm, B.B. gun or pellet gun.

Article 3

Any person who violates the provision of this by-law  
shall be guilty of an offence and liable on summary  
conviction to a fine not exceeding \$25.00 or to a term  
of imprisonment not exceeding 15 days or both.
