Notice is here by given that the Maria Mic-Mac Band of Indians at a meeting held this 27th day of April 1977 Make the following by-law pursuant to paragraph a,r,of section 81 of the Indian Act.

By-law #5

A by-law to prohibit the disposal or dumping of garbage. To provide for the health of residents on the Reserve and a provision of a fee.

Article 1

No person shall dump or otherwise dispose of any garbage on any lands whether owned,controlled by or on behalf of the Council or allotted to leased or otherwise used by an person within the Reserve.Except in those places set apart maintained and operated for such purpose.

Article 2

No person shall dump or otherwise dispose of garbage on any road or road allotted within the Reserve

Article 3

The Council will arrange for the removal of garbage and waste from any premises within the Reserve.

Article 4

All such matter shall be disposed of in such a manner that it will prevent any nuisance or offence as to the fouling of wells and water supply.

Article 5

In this by-law the Reserve dump will be open to the public Monday to Saturday,from the hours of 7.30A.M. to 9P.M. Being closed on Sunday.

Article 6

Being the decision of the Band a fee of 13.00 per year be paid to the Band Council for garbage collection. The Band Council will in turn pay the contractor on a monthly basis.

Article 7

Any person who violates any of the following provisions of this by-law shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding \$10.00 or imprisonment for a term not exceeding 7 days or both.

Approved and passed at a duly meeting of the Council of the Mic-Mac Band of Indians of Maria Reserve this 27th day April 1977.
