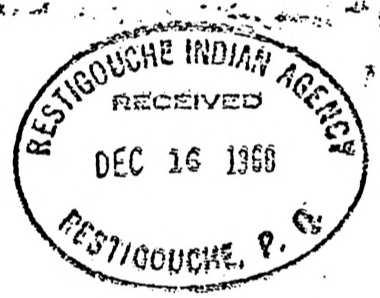

WE HEREBY RESOLVE:

Ask for approval of the attached by-law no. ¹⁷16
 No person shall throw or place into or upon any Street or sidewalk or private property within the Restigouche Indian Reserve any snow or ice brought from any yard, driveway, enclosure or roof of any building.
 This By-Law does not apply to the Snow removal Contractor hired by Band Council in the normal course of his work.
 Offenders will be subject to fine of not less than \$5.00 and or seven days in Jail for the first offence. Second offence and all subsequent offences increased by \$5.00 each.
