DO HEREBY RESOLVE:  
DÉCIDE, PAR LES PRÉSENTES:

WHEREAS, sections 81(g), (o), and (r) empower the Council of a Band to pass by-laws respecting the division of the reserve or a portion thereof into zones and the prohibition of the construction or maintenance of any class of buildings or the carrying on of any class of business, trade or calling in any such zone, and the preservation and protection of game on the reserve; and the imposition of a penalty for the violation of a by-law;

AND WHEREAS, certain lands in the Cold Lake Reserve #149 are especially rich in natural wildlife and have traditionally, by unwritten policy, been preserved;

NOW THEREFORE, the Council of the Cold Lake Band of Indians, in the Province of Alberta, makes as a by-law thereof as follows:

- In this by-law "Nature Preserve Zone" includes those parts of the Cold Lake Indian Reserve No. 149 more particularly described as follows:
  - all of section 2, all of section 11 except the NE 1/4 thereof, the south 1/2 of section 14, all of section 15, and all of section 22, all of which are in Township 61, Range 3, W. of the 4th Meridian; and
  - the south 1/2 of section 7, in Township 61, Range 2, W. of 4th Meridian.
- A portion of the Cold Lake Indian Reserve No. 149 is hereby set aside as a Nature Preserve Zone.

DÉCIDE, PAR LES PRÉSENTES:

3. (a) Within the Nature Zone the construction or maintenance of any class of building and the carrying on of any class of business, trade or calling is prohibited.
- (b) Without limiting the generality of the foregoing, a class of business, trade or calling includes agricultural pursuits.
4. Any person who violates any provision of this by-law shall be guilty of an offence, and shall be liable, on summary conviction, to a fine not exceeding \$100.00 or imprisonment for a term not exceeding 30 days, or to both fine and imprisonment.

Approved and passed at a duly convened meeting of the Council of the Cold Lake Band of Indians, in Alberta, this 21 day of January, 19 85.
