RATES BY-LAW

WHEREAS pursuant to the Indian Act, R.S.C. 1985, and specifically paragraph 83(1) (a) of the Indian Act, 1985 c.I-5. The Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matter arising out of our ancillary to such purpose;

AND WHEREAS THE Council of the Snuneymuxw First Nation enacted both the Nanaimo Indian Band Assessment By-law and the Nanaimo Band Taxation By-law on September 23, 1992, each of which received Minister's approval on January 23, 1993;

NOW BE IT HEREBY RESOLVED that the following by-law be and is herby enacted pursuant to the provisions of the Indian Act, and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- 1. This by-law may be cited for all purposes as the Snuneymuxw First Nation Taxation Rates By-law 2015-1.
- 2. Pursuant to the Nanaimo Indian Band Taxation By-law, the tax rates for each class of property shall be in accordance with Schedule "A", which is hereto attached, and forms part of the 2015 Taxation Rates By-law.

This by-law is hereby enacted by Council at the duly convened meeting held on the th day of October 2015.
