AND WHEREAS The Council of the Carry The Kettle First Nation enacted the Carry The Kettle Property Assessment and Taxation By-law on April 24, 2003;

BE IT RESOLVED THAT the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.
