BE IT KNOWN THAT this By-law entitled “the Rates By-Law” which form part of the Taxation By-law passed by Chief and Council and approved by the Minister on November 30th, 1995 that being a by-law to establish a by-law system on the Reserve lands of the Little Shuswap Indian Band for fair and equitable taxation for local purposes on land, or interests in land, including the right to occupy, possess or use lands within the boundaries of the Reserves is hereby enacted as By-law 2013-T02 by the Chief and Council of the Little Shuswap Indian Band.
