DO HEREBY RESOLVE: DECIDE, PAR LES PRÉSENTES

WHEREAS pursuant to subsection 83(1)(a) of the Indian Act, R.S.C. 1985, c.1-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such purpose; and

WHEREAS the Council of the Sturgeon Lake Cree Nation enacted the Sturgeon Lake Band Taxation and Business Licensing Bylaw on July 23, 1986,

NOW BE IT THEREBY RESOLVED

that the following resolution is hereby enacted pursuant to the provisions of the Indian Act and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- This by-law may be cited for all purposes as teh Sturgeon Lake Cree Nation Tax 1. Rates By-law 2013.
- Pursuant to section 21 of the Sturgeon Lake Band Taxation and Business Licensing By-law, the 2013 tax rates for each class of property shall be:
 - 1.85% (a) For non-residential
 - (b) For machinery and equipment 1.10%
- This By-law comes into force and effect upon being approved by the Minister of Indian Affairs and Northern Development.

This resolution is hereby enacted by Council at a duly convened meeting held on April 24, 2013.
