**WHEREAS** pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C. 1985, c.1-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such purpose; and

**WHEREAS** the Council of the Sturgeon Lake Cree Nation enacted the Sturgeon Lake Band Taxation and Business Licensing Bylaw on July 23, 1986,

**NOW BE IT THEREBY RESOLVED**

that the following resolution is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.



1. This by-law may be cited for all purposes as the *Sturgeon Lake Cree Nation Tax Rates By-law 2013*.
2. Pursuant to section 21 of the *Sturgeon Lake Band Taxation and Business Licensing By-law*, the 2013 tax rates for each class of property shall be:




- (a) For non-residential 1.85%
- (b) For machinery and equipment 1.10%



3. This By-law comes into force and effect upon being approved by the Minister of Indian Affairs and Northern Development.
