KWANTLEN FIRST NATION PROPERTY ASSESSMENT AND TAXATION RATES BY-LAW NO. 2013

WHEREAS pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C. 1985, c.I-5, the Council of Band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Kwantlen First Nation enacted the Kwantlen First Nation Property Assessment and Taxation By-law on July 26, 2004;

NOW BE IT HEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act*, and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- 1. This by-law may be cited for all purposes as the Kwantlen First Nation 2013 Rates By-law.
- 2. Pursuant to Section IV of the Kwantlen First Nation Property Assessment and Taxation By-law, there are hereby established, imposed and levied for the taxation year 2013 the tax rates for each class of property within each separate taxation district as set out in columns 2, 3 and 4 of Schedule "A".

THIS BY-LAW IS HEREBY ENACTED by Council at a duly convened meeting held on the 8^{+h} day of May, 2013.
