NADLEH WHUT'EN INDIAN BAND No. 612

RATES BYLAW 2006

WHEREAS pursuant to subsection 83(1)(a) of the Indian Act, R.S.C. 1985, c. I-5 the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matter arising out of or ancillary to such purpose;


AND WHEREAS the Council of the Nadleh Whut'en Indian Band, enacted the Nadleh Whut'en Indian Band Property Assessment and Taxation Bylaw on December 18, 1998;

NOW BE IT HEREBY RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the Indian Act and in particular section 83(1) for the purpose of establishing annual rates of taxation.


SHORT TITLE


1. This bylaw may be cited as the Nadleh Whut'en Indian Band Rates Bylaw 2006.
