BYLAW NO: 2010-01

WHEREAS:

Pursuant to subsection 83(1)(a) of the *Indian Act, R.S.C. 1985, c.1-5, the Council of a Band* may make bylaws for the purpose of taxation for local purposes of land, or interest in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS:

The Council of the Upper Similkameen Indian Band enacted the Upper Similkameen Property Assessment and Taxation Bylaw on December 13, 2002;

NOW BE IT RESOLVED:

That the following bylaw be and is hereby enacted pursuant to the provision of the Indian Act and in particular Section 83(1)(a) for the purpose of establishing annual rates of taxation.

- 1.) This bylaw may be cited as the Upper Similkameen Indian Band 2010 Rates Bylaw.
- 2.) Pursuant to Section 22 of the Upper Similkameen Indian Band Property Taxation Bylaw, the tax rates for each class of property shall be in accordance with Schedule "A", which is attached, and forms part of the 2010 Rates Bylaw.

This Bylaw is hereby enacted by Council at a duly convened meeting held on the 1st day of December, 2010.
