BY - LAW # 2.5

RECITAL: The Council of the Tsuu T'ina Nation therefore enacts the following By-Law:

SHORT TITLE: This By-Law be cited as Annual Budget By-Law 1992 (Tsuu T'ina Nation By-Law #2.5)


ANNUAL MILL RATE: The Mill Rate for the 1992 Taxation year is fixed at 54.64 Mills.

BUDGET AND EXPENDITURE: The Funds raised by taxation shall be included as General Revenue and expended in accordance with the attached Budget.

QUORUM: There are Ten (10) Council Members and a Quorum consists of six (6) Members.

THIS BY-LAW IS HERBY ENACTED BY THE COUNCIL AND THE TSUU T'INA NATION AT A DULY CONVENED MEETING OFF THE COUNCIL HELD ON NOVEMBER 4, 1992.


