

## Carry The Kettle First Nation 2005 Property Tax Rates Bylaw

**WHEREAS** pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C. 1985, c.I-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

**AND WHEREAS** the Council of the Carry The Kettle First Nation enacted the *Carry The Kettle Property Assessment and Taxation Bylaw* on April 24, 2003;

**NOW BE IT THEREBY RESOLVED** that the following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This bylaw may be cited for all purposes as the *Carry The Kettle First Nation 2005 Tax Rates Bylaw*
2. Pursuant to section 11 of the *Carry The Kettle Property Assessment and Taxation Bylaw*, the rate of tax applied against the assessed value of property shall be 2.7923%.

This bylaw is hereby enacted by Council at a duly convened meeting held on MAY 31<sup>ST</sup> 2005.
