2004 RATES BY-LAW

BY-LAW NO. 2004-

WHEREAS pursuant to subsection 83(1) of the *Indian Act*, the Council of a Band may make by-laws for the purpose of taxation for local purposes of land, or interest in land including the rights to occupy, possess or use lands within the boundaries of a Reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Tla-o-qui-aht First Nations enacted the Tla-o-qui-aht First Nations Property Tax By-law on August 9, 1995;

NOW BE IT HEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular to Section 83(1) for the purpose of establishing annual rates of taxation.

- 1. This By-law may be cited for all purposes as the *Tla-o-qui-aht First Nations* 2004 Rates By-law.
- 2. Pursuant to Section 11 of the *Tla-o-qui-aht First Nations Property Tax By-law*, the rates of each class of property shall be in accordance with Schedule "A" which is attached and forms part of the By-law.
