COWICHAN INDIAN BAND

A Bylaw to Fix Tax Rate and Percentage Additions for the Year 2000

WHEREAS:

- A. The Cowichan Indian Band "Property Assessment and Taxation Bylaw" was made pursuant to Subsection 83(1) of the Indian Act for the purpose of taxation for local purposes of land, or interests in land, in the "reserve" (as defined in the Property Assessment and Taxation Bylaw) including rights to occupy, possess or use land in the "reserve".
- B. Subsection 83(1)(e.1) provides for the imposition and recovery of interest on amounts that are payable pursuant to this section, where those amounts are not paid before they are due, and the calculation of that interest.

NOW BE IT HEREBY RESOLVED THAT the following bylaw be and is hereby enacted pursuant to the provisions of the <u>Indian Act</u> and in particular Subsection 83(1) thereof, for the purpose of fixing a tax rate and percentage additions for the year 2000.

Short Title

1. This bylaw may be cited for all purposes as the "Cowichan Indian Band Bylaw to Fix Tax Rate and Percentage Additions for the Year 2000".

Tax Rates

2. The following rates are hereby imposed and levied for the Calendar Year 2000 on the assessed value of land and improvements by property class.

3. The Tax Collector of the Cowichan Indian Band shall on September 19, 2000 add ten per cent (10%) on to the current year's taxes unpaid on each parcel of land and on the improvements thereon, and the said unpaid taxes including tax rates together with the amounts added aforesaid, shall be deemed to be taxes of the current year due on such land and on the improvements thereon.

Interest on Taxes in Arrears

Taxes in Arrears are subject to interest at the prevailing Bank of Canada rate plus 2% 4. calculated from January of the year following. Interest charged will be calculated at the Bank of Canada rate (plus 2%) in effect on the date the taxes in arrears are paid.

Place of Tax Payments

The tax rates and percentage additions shall be payable at the office of the Tax Collector at the 5. Cowichan Band Office, 5760 Allenby Road, Duncan, BC. Mailing address: Cowichan Tribes, 5760 Allenby Road, Duncan, BC V9L 5J1.
