TAXATION BYLAW

TL'AZT'EN NATION RATES BYLAW 2011

WHEREAS pursuant to subsection 83(1) (a) of the *Indian Act*, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matter arising out of or ancillary to such purpose; and,

WHEREAS the Council of the Tl'azt'en Nation enacted the Tl'azt'en Nation Property Assessment and Taxation By-law on the 25th day of October 1996;

NOW BE IT HEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1)(a) for the purpose of establishing annual rates of taxation.

- This byław may be cited for all purposes as the Tl'azt'en Nation Rates By-law 2011.
- 2. Pursuant to Section V of the Tl'azt'en Nation Property Assessment and Taxation By-law, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the 2011 Rates By-law.

This by law is hereby enacted by Council at a duly convened meeting held in Tache, B.C. on the 30th day of August, 2011.
