

### TAXATION BYLAW

#### TL'AZT'EN NATION RATES BYLAW 2004

WHEREAS pursuant to subsection 83(1(a)) of the *Indian Act*, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such purpose; and,


WHEREAS the Council of the TL'azt'en Nation enacted the TL'azt'en Nation Property Assessment and Taxation By-Law on the 25<sup>th</sup> day of October 1996;

NOW BE IT HEREBY RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1(a)) for the purpose of establishing annual rates of taxation.

1. This bylaw may be cited for all purposes as the TL'azt'en Nation 2004 Rates Bylaw.
2. Pursuant to Section V of the TL'azt'en Nation Property Assessment and Taxation Bylaw, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the 2004 Rates Bylaw.

This bylaw is hereby enacted by Council at a duly convened meeting held in Tachie, B.C. on the 7<sup>th</sup> day of June, 2004.






