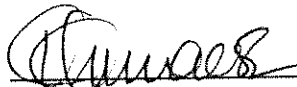

DO HEREBY RESOLVE:
DÉCIDE, PAR LES PRÉSENTES:

THAT WHEREAS : pursuant to subsection 83 (1) of the Indian Act, the Council of a Band may make bylaws for the purpose of taxation for local purposes of land, or interest in land including the rights to occupy, possess or use lands within the boundaries of the Reserve and with respect to any matters rising out of or any ancillary to such purpose :

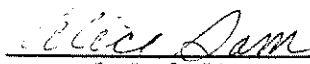
AND WEREAS : the Council of the Shuswap Indian Band enacted the Shuswap Indian Band Taxation and Assessment Bylaw on March 9th, 1992;

NOW BE IT HEREBY RESOLVED : that the following bylaw be and is hereby enacted pursuant to the provisions of the Indian Act and in particular section 83 (1) for the purpose of establishing annual rates of taxation.

1. This bylaw may be cited for all purposes as the Shuswap Indian Band 2001 Rates Bylaw.
2. Pursuant to section 24 of the Shuswap Indian Band Taxation Bylaw, the rates for each class of property shall be in accordance with the Schedule "A" which is attached, and forms part of the 2001 Rates Bylaw.

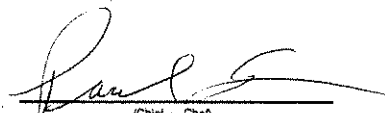
