

BE IT KNOWN THAT THIS BYLAW ENTITLED "RATES BYLAW" WHICH FORMS PART OF THE TAXATION BYLAW PASSED BY CHIEF AND COUNCIL, AND APPROVED BY THE MINISTER ON MARCH 9, 1992, THAT BEING A BYLAW, TO ESTABLISH BY BYLAW A SYSTEM ON THE RESERVE LANDS OF THE ST.MARY'S INDIAN BAND FOR THE FAIR AND EQUITABLE TAXATION FOR LOCAL PURPOSES OF LAND, OR INTERESTS IN LAND, INCLUDING THE RIGHTS TO OCCUPY, POSSESS OR USE LANDS WITHIN THE BOUNDARIES OF THE RESERVES IS HEREBY ENACTED AS BYLAW 1999 - T07 BY THE CHIEF AND COUNCIL OF THE ST.MARY'S INDIAN BAND.
