WESTBANK INDIAN BAND

By-Law No. 1992-01
of the Westbank Indian Band

A BY-LAW TO AMEND THE TAXATION BY-LAW PASSED BY CHIEF AND COUNCIL AUGUST 17TH, 1990 AND APPROVED BY THE MINISTER AUGUST 31ST, 1990, THAT BEING A BYLAW TO ESTABLISH BY BY-LAW A SYSTEM ON THE RESERVE LANDS OF THE WESTBANK INDIAN BAND FOR THE FAIR AND EQUITABLE TAXATION FOR LOCAL PURPOSES OF LAND, OR INTERESTS IN LAND INCLUDING RIGHTS TO OCCUPY, POSSESS OR USE LAND IN THE RESERVE.

WHEREAS pursuant to Section 24 (2) of the Westbank Indian Band Taxation By-Law, Chief and Council shall prescribe tax rates and;

WHEREAS those tax rates prescribed by the Chief and Council are set out in Schedule "A" to the Westbank Indian Band Taxation By-Law pursuant to section 24 (5) and;

WHEREAS the Chief and Council of the Westbank Indian Band deems it advisable and in the best interests of the members of the Westbank Indian Band to amend the Taxation By-law passed by Chief and Council August 17, 1990 and approved by the Minister August 31st, 1990, that being a by-Law to establish by by-law a system on the reserve lands of the Westbank Indian Band for the fair and equitable taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in the reserve;

NOW THEREFORE the Chief and Council of the Westbank Indian Band enacts as an amending by-law;

Short Title

This amending by-law may be cited as the "Tax Rates: 1992 Amending By-Law".

1. The Council of the Westbank Indian Band repeals subsection 24 (5) of the Westbank Indian Band Taxation By-Law and enacts as an amending by-law the following:

24 (5)

The variable tax rates for 1991 and for each year thereafter prescribed by the Chief and Council pursuant to section 24 (2) are those tax rates set out in the Schedules to this by-law, such tax rates to be applied against each one thousand dollars (1,000.00) of actual value of property in each respective class as set out in the Schedules to this by-law".

2. That the following Schedule "C" shall be added to the Westbank Indian Band Taxation By-Law passed by Chief and Council August 17th, 1990 and approved the Minister August 31st, 1990 -:
