**WESTBANK INDIAN BAND
PROPERTY TAXATION AMENDMENT BY-LAW
BY-LAW NO. 1994-TAX-05**

WHEREAS the Band Council of the Westbank Indian Band deems it advisable and in the best interests of the band to continue to engage in the taxation for local purposes of land, or interests in land, in the reserve lands of the Westbank Indian Band, including rights to occupy, possess or use land in the reserve lands of the Westbank Indian Band;

NOW BE IT HEREBY RESOLVED THAT the Property Taxation Amendment By-law be and is hereby enacted for the purpose of continuing assessment and taxation for local purposes of land, or interests in land, in the reserve, including rights to occupy, possess or use land in the reserve, pursuant to the provisions of the Indian Act and in particular pursuant to the provisions of subsection 83(1) of the Indian Act;
