DO HEREBY RESOLVE:

WHEREAS Pursuant to subsection 83(1) (a) of the Indian Act, R.S.C. 1985, c.1-5, the Council of a Band may make bylaws for the purpose of taxation for local purposes of land, or interest in land including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such purpose;

AND WHEREAS the Council of the Upper Similkameen Indian Band enacted the Upper Similkameen Indian Band Property Assessment and Taxation Bylaws on December 13, 2002;

NOW BE IT RESOLVED That the following bylaws be and is hereby enacted pursuant to the provisions of the Indian Act and in particular Section 83(1)(a) for the purpose of establishing annual rates of taxation.

- 1. This bylaw maybe cited as the Upper Similkameen Indian 2011 Rates Bylaw.
- 2. Pursuant to Section 22 of the Upper Similkameen Indian Band Property Taxation Bylaw, the tax rates for each class of property shall be in accordance with Schedule "A", which is attached, and forms part of the 2011 Rates Bylaw.

This Bylaw is hereby enacted by Council at a duly convened meeting held on the 3rd day of OCTOBER 2011
