The Chief and Council of the Osoyoos Indian Band hereby enacts as follows:

1. The following rates are hereby imposed and levied on the various classes of property use for the year 1995, applicable to the whole of Osoyoos Indian Reserves

As soon as practicable on or after the 4th day of July, 1995, the Surveyor of Taxes of the Osoyoos Indian Band shall add to the current year's taxes unpaid as at 4:30 p.m. on the 4th day of July, 1995, on each parcel of land on his Roll, ten per centum (10%) of the amount thereof and the said unpaid taxes, together with amounts added as aforesaid shall from the 4th day of July, 1995, be deemed to be the amount of the current year's taxes upon such land.
