BYLAW No. 2003-1

FIRST NATION TAX RATES BYLAW

WHEREAS pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C. 1985, c. 1-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose:

AND WHEREAS the Council of the T'it'q'et First Nation (also formally known as the Lillooet Indian Band) enacted the Lillooet Indian Band Assessment and Taxation Bylaws on September 23, 1992;

NOW BE IT HEREBY RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act*, and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- 1. This bylaw may be cited for all purposes as the T'it'q'et First Nation 003 Rates Bylaw.
- 2. Pursuant to Section 3 of the T'it'q'et First Nation Tax Bylaw, the tax rates for each class of property shall be in accordance with Schedule, "A" which is attached, and forms part of the 2003 Rates Bylaw.

This bylaw is hereby enacted by Council at a duly convened meeting held on the 31 day of July, 2003.
