## CHAWATHIL FIRST NATIONS RATES BYLAW

WHEREAS pursuant to the subsection 83(1)(a) of the Indian Act the Council of the band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Chawathil First Nations, (also known as the Hope Indian Band) enacted the Chawathil First Nation Property Assessment and Taxation Bylaw on December 20<sup>th</sup>, 1994;

**NOW BE IT HEREBY RESOLVED** that the following bylaw be and is hereby enacted pursuant to the provisions of the Indian Act and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- 1. This bylaw may be cited for all purposes as the Chawathil First Nations 2000 Rates Bylaw.
- 2. Pursuant to section 30 of the Chawathil First Nations Property Assessment and Taxation Bylaw, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the 2000 Rates Bylaw.

This bylaw is hereby enacted by the Council at a duly convened meeting held on the 2nd day of May, 2000.

The Council of the Chawathil First Nations hereby adopts the following taxation rates for the 2000 taxation year for the following classes of property.
