WHEREAS pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C. 1985, c.I-5, the Council of a Band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Kwaw Kwaw Apilt First Nation (also known, as the Kwaw Kwaw Apilt Indian Band) enacted the *Kwaw Kwaw Apilt First Nation Property Assessment Bylaw Amendment 1-1995* and the *Kwaw Kwaw Apilt First Nation Property Taxation Bylaw Amendment 1-1995* on December 08, 1995;

NOW BE IT HEREBY RESOLVED that the following Bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This Bylaw may be cited for all purposes as the Kwaw Kwaw Apilt First Nation Rates Bylaw No. 2006.
2. Pursuant to Section 3 of the *Kwaw Kwaw Apilt First Nation Property Assessment Bylaw Amendment 1-1995*, the tax rates for each class of property shall be in accordance with Schedule "A-1" which is attached, and forms part of the Kwaw Kwaw Apilt First Nation Rates Bylaw No. 2006.

This Bylaw is hereby made and approved at a duly convened meeting of the Chief and Council of the Kwaw Kwaw Apilt First Nation, also known as the Kwaw Kwaw Apilt Indian Band, this 12 day of JUNE, 2006.
