WHEREAS pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C. 1985, c.I-5, the Council of a Band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Leq'á:mel First Nation (also known, as the Lakahahmen Indian Band) enacted the *Leq'á:mel First Nation Property Assessment Bylaw Amendment 1-1995* and the *Leq'á:mel First Nation Property Taxation Bylaw Amendment 1-1995* on February 21, 1995;

NOW BE IT HEREBY RESOLVED that the following Bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This Bylaw may be cited for all purposes as the **Leq'á:mel First Nation Rates Bylaw No. 2005**.
2. Pursuant to Section 3 of the *Leq'á:mel First Nation Property Assessment Bylaw Amendment 1-1995*, the tax rates for each class of property shall be in accordance with **Schedule "A-1"** which is attached, and forms part of the Leq'á:mel First Nation Rates Bylaw No. 2005.
