**KWANTLEN FIRST NATION
PROPERTY ASSESSMENT AND TAXATION
AMENDMENT BY-LAW NO. 02-2009**

WHEREAS:

- A.** It is the practise of the Chief and Council of Kwantlen First Nation to enact a by-law annually, establishing rates of taxation to be applied to the assessed value of interests in land in its reserves;
- B.** It is an objective of the taxation conducted under the provisions of the Kwantlen First Nation Property Assessment and Taxation By-law to ensure certainty and fairness for the taxpayers on the First Nation's reserves and for the First Nation;
- C.** The Chief and Council of Kwantlen First Nation wishes to amend the Property Assessment and Taxation By-law to ensure that the objectives set out in the above Recitals A and B is given effect for the 2009 taxation year.

NOW BE IT HEREBY RESOLVED that the following by-law be and is hereby enacted for the purpose of amending certain provisions of the Kwantlen First Nation Property Assessment and Taxation By-law for the 2009 year as hereinafter provided.

- 1. This by-law may be cited as the *Kwantlen First Nation Property Assessment and Taxation Amendment Bylaw No. 02-2009*
- 2. The Kwantlen First Nation Property Assessment and Taxation By-law is amended as follows:
 - (a) Section 46(1) the date taxes levied are due and payable as of "June 30" of the year is amended to read "September 30".
 - (b) Section 49 the "July 1" date ten percent (10%) penalty shall be added is amended to "October 1"

This Amendment By-law is applicable only to the 2009 taxation year.

THIS AMENDMENT BY-LAW IS HEREBY ENACTED by Council at a duly convened meeting held on the 30 day of June, 2009.

Quorum is two council members.
