DO HEREBY RESOLVE: WHEREAS the Stoney Tribal Council is empowered to act for and on behalf of the people of the Bearspaw, Chiniki and Wesley Bands; and,

WHEREAS the Stoney Tribal Council has met in quorum at a duly convened meeting on the 26th day of MARCH, 2003; and,

WHEREAS pursuant to subsection 83(1)(a) of the Indian Act, R.S.C. 1985, c.1-5, the Council of a band may make 'aws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose; and,

WHEREAS the Council of the Stoney First Nation enacted the Stoney Property Tax Bylaw on July 09th, 1992.

THEREFORE BE IT RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the Indian Act and in particular section 83(1) for the purpose of establishing annual rates of taxation:

- This bylaw may be cited for all purposes as the Stoney First Nation 2003 Tax Rates Bylaw;
- Pursuant to section 11 of the Stoney Property Tax Bylaw, the rate of tax applied against each \$1,000.00 of the assessed value of property shall be:
 - (a) for property other than machinery and

equipment or residential

1.38%

(b) for machinery and equipment 0.68%

(c) for residential property

0.97%
