

Whitefish Lake First Nation Property Tax Bylaw Amendment

WHEREAS pursuant to subsection 83(1)(a) of the Indian Act R.S.C. 1985 c.1-5 the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interest in land, including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such purpose;
and


WHEREAS the Council of the Whitefish Lake First Nation enacted the Whitefish Lake First Nation Property Tax Bylaw on December 4, 1998; and

WHEREAS the Council of the Whitefish Lake First Nation deem it advisable to amend the Bylaw to provide a time frame for taxation in the 1999 tax year;


THEREFORE BE IT RESOLVED that the Council of the Whitefish Lake First Nation enacts the following amendments to the Whitefish Lake First Nation Property Tax Bylaw,

1. Section 5.2 is amended by adding at the end of the section:, except for the 1999 taxation year in which taxes are due as of September 30.
2. Section 7.3.1 is amended by striking out 'May 1' and replacing it with September 1.
3. Section 8.1 is amended by striking out 'May 1' and replacing it with September 1.
4. Section 12.1 is amended by adding at the end of the section:, except for the 1999 taxation year in which taxes are due and payable as of September 30.


This bylaw is hereby enacted by Council at a duly convened meeting held on the 9th day of August 1999.


