WHEREAS the Council of the Enoch Band of Indians of the Stony Plain Indian Reserve No. 135 in the Province of Alberta desires to make by-laws for the purposes contained in section 83 of the *Indian Act* R.S.A. 1985, c. I-5, as amended;

AND WHEREAS the Council has caused an assessment of all property shown on the assessment roll for 1991; and

AND WHEREAS the Council has approved a budget for the 1991-92 expenditures for the Band in the areas of education, public works, recreation, protection and administration;

THEREFORE BE IT RESOLVED THAT the Council of the Enoch Band hereby enact a budget by-law to establish the 1991 mill rate and allocation for the expenditure of revenues derived from taxation as follows:

1991 Mill Rate

Commercial, industrial, vacant land and improvements at 31.464 mills, and electrical power and pipeline at 31.69 mills.
