DO HEREBY RESOLVE: DÉCIDE, PAR LES PRÉSENTES:

WHEREAS pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C., 1985, c-I-5, the Council of a Band my make bylaws for the purpose of taxation for local purposes of land, or interest in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Alexander First Nation enacted the Alexander First Nation Property Assessment and Taxation Bylaw on June 7, 2002;

NOW THEREFORE BE IT RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- 1. This bylaw may be cited for all purposes as the Alexander First Nation 2003 Tax Rates Bylaw.
- 2. Pursuant to section 11 of the Alexander First Nation Property Assessment and Taxation Bylaw, the rate of tax applied against the assessed value of the land and improvements for tax year 2003 shall be:

In Reserve No 134:

- a) For machinery and equipment 1.50%
- b) For property other than machinery and equipment 2.15%

In Reserve No 134A:

A) For property other than machinery and equipment 1.20%
