**DO HEREBY RESOLVE:**

WHEREAS a quorum of Chief and Council met at a duly convened meeting on Tuesday, April 11, 2006;

AND WHEREAS pursuant to the Indian Act and their inherent right to self-government the Chief and Council is empowered to make decisions on behalf of the membership of the Alexis Nakota Sioux Nation;

AND WHEREAS pursuant to subsection 83(1) (a) of the Indian Act, R.S.C. 1985, c.1-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interest in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Alexis Nakota Sioux Nation enacted the Alexis First Nation Property Bylaw on July 1999.

THEREFORE BE IT RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the Indian Act and in particular section 83(1) for the purpose of establishing annual rates of taxation:

1. This bylaw may be cited for all purposes as the Alexis Nakota Sioux Nation 2006 Tax Rates Bylaw
2. Pursuant to section 5 of the Alexis First Nation Property Tax Bylaw, the rate of tax applied against the assessed value of property for the 2005 tax year shall be:
