**DO HEREBY RESOLVE
DÉCIDE, PAR LES PRÉSENTES**

The Tribal Council of the Siksika Nation, without prejudice to but in express affirmation of its right of self-government, enacts the following as law:

1. Section 6 (with respect to exemption from taxation) of the Siksika Nation Land Tax By-Law, adopted on January 9, 1990, is amended by adding the following clauses:
 - (i) land, buildings, pipes, machinery and equipment that are part of a natural gas distribution system serving residents of the reserve.
 - (j) land, buildings, equipment and rights of way that are part of a rail transportation system.
