RATES BYLAW NO. 2008-02


WHEREAS pursuant to the *Indian Act* R.S.C. 1985, and specifically paragraph 83(1)(a) of the *Indian Act*, 1985, c. I-5, the Council of a Band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Chief & Council of the Ocean Man First Nation (also known as the Ocean Man Band) enacted the Ocean Man First Nation Property Assessment and Taxation Bylaw on June 07, 1999;

NOW BE IT HEREBY RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act*, and in particular section 83 (1) for the purpose of establishing annual rates of taxation.


1. This bylaw may be cited for all purposes as the Ocean Man First Nation Rates Bylaw 2008.
2. Pursuant to Section eleven (11) of the Ocean Man First Nation Property Assessment and Taxation Bylaw, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the 2008 Rates Bylaw.


This bylaw is hereby enacted by the Chief & Council at a duly convened meeting held on the 19th day of August, 2008.


