DO HEREBY RESOLVE: DÉCIDE, PAR LES PRÉSENTES:

WHEREAS; pursuant to subsection 83(1)(a) of the Indian Act, R.S.C. 1985, c.1-5, the Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Carry The Kettle First Nation enacted the Carry The Kettle Property Assessment and Taxation By-Law on April 24, 2003;

NOW BE IT THEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the Indian Act and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- This by-law may be cited for all purposes as the Carry The Kettle First Nation 2008 Tax Rates By-Law.
- Pursuant to section 11 of the Carry The Kettle Property Assessment and Taxation By-law, the rate of tax applied against the assessed value of property shall be 3.0512%.

This by-law is hereby enacted by Council at a duly convened meeting held on June 26, 2008.
